Districts may nominate one adult per year for membership into the Order of the Arrow. The following conditions are the basis for candidate selection and MUST be fulfilled to be considered. 1. Selection of the adult is based upon ability to perform the necessary functions and not for recognition of service, including current or prior achievement and position. The individual's abilities include:

3. The camping requirements that apply for youth candidates apply for adult candidates from Units and must have been fulfilled within the most recent two years prior to recommendation for membership. (This requirement does not apply to District/Council recommendations) The requirement, which is a minimum of fifteen days and nights of camping, which must include six days and five nights of resident camping approved and under the auspices and standards of the Boy Scouts of America, was fulfilled as follows;
